According to the decree n° 11217 of February 15, 2014;
According to the law of associations promulgated on August 3, 1909 and particularly article six thereof;
According to the Memo n° 10/M/ 2006 of May 19, 2006 and its modification N° 15/M/2008 dated 12/09/2008;
According to the notification presented to the Ministry of Interior and Municipalities by the founders of the association named:

“LEBANESE ALTERNATIVE LEARNING”

Registered before the Common Administrative Department under N° 21566 dated 30/12/2013;
According to the proposal of the director general of political and refugees affairs;

Decides the following

First article: The Ministry of Interior and Municipality took note of the incorporation of the association named **“LEBANESE ALTERNATIVE LEARNING”**.

Head Office: Beirut – Monot Street, Land circumscription of Saifi, real estate N° 43, section N° 12, Hugo Building, second floor.

Purpose:

The purpose of the assembly is in general:

- 1- Contribution in providing education for all.
- 2- Contribution in avoiding school dropout.
- 3- Contribution in providing internet electronic solutions to continue education no matter the economical, social, health and security circumstances are.
- 4- Contribution in gathering the best academics and best IT specialists to innovate suitable tools.

In general, the assembly may carry out all kinds of activities within the context of its object, including working on issuing periodical and non periodical bulletins and publications, contributing in creating cultural and research centers as well as all types of nonprofit educational and scientific institutions and other activities related directly or indirectly in the subjects mentioned above.

It may carry out all of these activities separately or jointly or by cooperation or contribution with individuals, official authorities, research centers,

associations, companies, syndicates, universities, schools or other institutions that has the same object or a similar object in Lebanon and abroad.

Provided that the aforementioned articles shall be applied according to laws and regulations in force and after the approval of the competent authorities

Article 2: The Constituent committee shall complete the procedures of the association incorporation and convoke to elect an administrative committee within one year from the publication date of this notice in the official gazette.

Article 3: The above mentioned association shall present to the Ministry of Interior and Municipalities at the first month of each year a list including the names of its members, copy of its annual balance sheet and of its previous fixed account, otherwise, it will be subject to the provisions of the law promulgated in the decree n° 10830 of Oct. 9, 1962 and its related amendments.

Article 4: This Notice shall be notified to whom it may concern.
